<b>Program Description</b>	<p>The Flight Instructor Rating (FIR) program trains candidates to the standard required to become class 4 flight instructors in Canada.</p> <p>The program is intended to provide ground knowledge and flight training of the principles of instruction in order to pass the Transport Canada (TC) AIRAF exam and the Class 4 Initial Flight Test.</p>
<b>Career Occupations</b>	Flight Instructor, Airline Pilot, Training Pilot, Ground School Instructor.
<b>Admission Requirements</b>	<ol style="list-style-type: none"> <li>1. Valid TC Category 1 medical.</li> <li>2. Valid Canadian Commercial Pilot Licence or Canadian Airline Transport Pilot Licence.</li> </ol>
<b>Learning Objectives</b>	<p>Upon completion of this program the successful student will demonstrate:</p> <ol style="list-style-type: none"> <li>a. An understanding of the principles of flight instruction and the flight instructor guide.</li> <li>b. Use of the flight training manual.</li> <li>c. Use of lesson plans.</li> <li>d. A passing mark of 70% on the Transport Canada AIRAF exam and Initial class 4 flight test.</li> <li>e. Knowledge of safety and safety concepts as they relate to flight instruction.</li> </ol>
<b>Required course materials</b>	Single engine aircraft, Flight Training Device (FTD), Pilot Operating Handbook, TC Flight Instructor Guide, TC Flight Test Guide, Human Factors for Aviation Instructor Guide, Current VTA chart and Flight supplement, LFS Instructor Rating Textbook, Flight Scheduling software and Lesson Plans.
<b>Duration</b>	76 hours (approximately 5-6 weeks).
<b>Homework Hours</b>	30 hours
<b>Delivery Method</b>	In-class instruction, aircraft and FTD flight training
<b>Teaching Methods</b>	Lecture/Guided-Discussion/In-Flight Instruction.
<b>Method(s) of Student Evaluation</b>	Students will be assigned homework, individual topics for discussion, and in class quizzes.
<b>Completion Requirements</b>	Successfully complete 25 hours of ground and 30 hours of flight training in accordance with the Canadian Aviation Regulations.

## STATEMENT OF STUDENT RIGHTS

**Langley Flying School** is certified with the Private Training Institutions Regulatory Unit (PTIRU) of the British Columbia Ministry of Post-Secondary Education and Future Skills.

Before you enroll at a certified private training institution, you should be aware of your rights and responsibilities.

You have the right to be treated **fairly** and **respectfully** by the institution.

You have the right to a **student enrolment contract** that includes the following information:

- amount of tuition and any additional fee for your program
- refund policy
- if your program includes a work experience, the requirements to participate in the work experience and the geographic area where it will be provided
- whether the program was approved by PTIRU or does not require approval.

Make sure you read the contract before signing. The institution must provide you with a signed copy.

You have the right to access the institution's **dispute resolution process** and to be **protected against retaliation** for making a complaint.

You have the right to make a **claim** to PTIRU for a **tuition refund** if:

- your institution ceased to hold a certificate before you completed an approved program
- you were misled about a significant aspect of your approved program.

You must file the claim within **one year** of completing, being dismissed or withdrawing from your program.

<ul style="list-style-type: none"> <li>More than seven days after student signed the enrolment contract, and</li> <li>Before the program start date.</li> </ul>	Institution may retain up to 10% of tuition, to a maximum of \$1,000 paid or payable under a contract.

**Completed** means the student has received an evaluation of their performance for the specified percentage of hours of instruction. Only hours of instruction for which the student received an evaluation should be included in the calculation of a tuition refund. If a student completed a portion of a program for which they did not receive an evaluation, that portion should not be included in the calculation of the percentage of the program completed.

## Refund of Aircraft Utilization Fees
